

## Compliance Made Simple

San José businesses must comply with AB 341 (a state-mandated recycling program), SB 1383 and AB 1286 (state-mandated organics recycling programs) by setting up service and sorting waste material into the correct Wet (organic) and Dry (recyclables and everything else) containers. Customized service is an additional option for businesses that generate large volumes of non-soiled recycling (i.e., plastic bottles, glass, paper, and non-soiled cardboard). Dry and Customized materials are sent to Republic's Materials Recovery Facility (MRF) at the Newby Island Recyclery for sorting and processing. The Wet bin organic waste is first sent to an anaerobic digestion (AD) facility in San José to be processed and converted into electricity, and then sent for further processing into compost. ### Service Options

Per state and local laws, businesses are directed to sort their solid waste with one of the below options:

#### Option 1: Wet and Dry

- Wet (green container with black lid): non-edible food waste, landscape waste, food-soiled napkins & paper towels, food-soiled paper dishware, and food-soiled paper & cardboard
- Dry (blue container with black lid): recyclables and everything else

#### Option 2: Wet, Dry and Customized

- Wet (green container with black lid): non-edible food waste, landscape waste, food soiled napkins & paper towels, food-soiled paper dishware, and food soiled paper & cardboard
- Customized (white container with blue lid): non-soiled recyclables
- Dry (blue container with black lid): everything else

### Collection Container Sizes

All service options are available in multiple container sizes. Businesses can select the container(s) that best suits their needs:

- Carts: 32, 64, or 96 gallons
- Bins: 1 - 8 cubic yards
- Roll-Off Boxes or Compactors: 10 - 40 cubic yards

### In-House Receptacles

Per AB 827, businesses are required to have receptacles with signage for employees and customers to dispose of waste. Receptacles are often indoors (e.g., breakrooms, conference rooms, seating areas, etc.), but are sometimes also outdoors (e.g., staff break area, patio seating, etc.). Implementing this at your business is simple.

1. Set up collection container service.
2. Set up receptacles throughout your business that correspond with your collection container service.

3. Label and display posters above or next to the receptacles.
4. Use clear bags when possible to help with sorting.
5. Use Republic Services decals to properly label the containers.

- Non-Soiled Rigid Plastics
- Non-Soiled Glass
- Empty Bottles & Cans
- Scrap Metal
